



# Multi-Pure's National Rental Program

## National Rental Program Description

1. The following drinking water systems are available on this program: MPAD, MPCT, and MP750 series systems.
2. Monthly rental is \$19.50 per month.
3. First and last month's rent due at time of order.
4. All payments (including first and last month's payments) and security deposit, must be paid by credit card.
5. Monthly payment will automatically be charged to the customer's credit card on file each month.
6. Rental program is only available on the automatic credit card program.
7. A security deposit of \$50 is required at the time the order is placed for all stainless steel rentals. The deposit will be charged to the credit card at the time the order is received. If the customer should default on payment, the customer will forfeit this deposit.
8. Customers in good standing will receive a free replacement filter every 12 months.
9. Maintenance parts for the rental customer's unit will be provided at no additional charge, assuming that the account is in good standing.
10. Only one rental unit per customer.
11. To return the rental unit, the customer must contact Multi-Pure (not the selling distributor) directly and arrange to have the rental unit returned. Upon receipt of the rental unit, Multi-Pure will terminate the rental contract. The cost to return the rental unit to Multi-Pure is the responsibility of the rental customer.
12. There is no shipping and handling charge to send the rental unit to the customer.
13. Other promotions are not available with this program.
14. A rental unit can not count as a new distributor's qualifying purchase.

## Purchasing Your Rental Unit

*Rental customers can at any time choose to convert their rental system into a purchase. They can purchase the system they are renting or any of our other models.*

1. Rental customers can credit 50% of payments made towards the purchase of their rental unit or any other Multi-Pure drinking water system.
2. Maximum rental credit of \$117 on an MPAD or \$200 on a stainless steel system can be applied towards the purchase of the rental unit.
3. If the order is to be financed on our 0% financing program, a minimum down payment of \$100 (stainless steel units) or \$75 (MPAD) is required. Rental credit earned and security deposit (if available) will be applied towards this minimum downpayment. The balance due can be financed for up to 12 additional months.

## Distributor Commissioning information

1. No commission is paid on the first/last month's rent that is collected at the time the order is placed.
2. No commission is paid on the refundable security deposit, unless it is applied towards the purchase of the rental unit.
3. PNV of \$19.50 will be applied for each payment made (including first and last month's payments). MALV will be awarded in the standard fashion. No volume is given on the security deposit.
4. Commission will be paid on the monthly amount of \$15 (vs \$19.50).
5. Distributors and their upline, will receive standard commission based on the commissionable amount of \$15.  
Example: Master Builders will receive 35% commission.
6. Commission is paid on all ten levels as it is on a "paid in full" or financed order.
7. Distributors and their upline will continue to receive commission for as long as the customer rents this drinking water system.
8. Commission is not paid on the FREE replacement filter given to the rental customer as part of the rental program.
9. No commission is paid to the selling distributor on the rental credit that is being applied to the purchase.  
However commission will be paid on the customer's balance due.
